Enrollment Agreement

Tuition Agreement

1. Tuition must be paid for at time of enrollment to ensure a place in the class. Payments can either be mailed or paid in person. Tuition is due by the 10th of each month. If payment is not received by the date due, then a fee of \$20.00 will be assessed. If tuition is mailed in then it must be received before the 10th of the month or a \$20.00 fee will be assessed. **PowerHouse Dance is not responsible for reminding families when tuition is due.**
2. There will be a \$25.00 fee on all returned checks.
3. There is an annual enrollment fee of \$40.00 per student, except for in the summer. Families that enroll 2 or more children pay \$40.00 for the first child and \$20.00 for each additional child.
4. Fees are not pro-rated and tuition is not refundable.
5. If a class is missed, no credit will be given.
6. PHD will continue to bill you if you discontinue a class until you contact the studio at (913)888-0999 or powerhousedance@comcast.net. If you are discontinuing a class you must put it in writing with the date on it in order for PowerHouse Dance to know to stop billing you.
7. If you are late picking up your dancer after their class is over, then you will have to pay the instructor the waiting on your dancer. For every 5 minutes you are late, then a \$5.00 fee will need to be given to the instructor waiting on your dancer to be picked up. If this fee is not paid for at the time you are late picking up your dancer, then you will receive an invoice. **This is for the last scheduled class of the day.**
8. If you wish to pay monthly, then you just need to make sure that you make your payments on time and no later than the 10th of each month or you will receive a \$20.00 late fee. Invoices are not given out for tuition.
9. Tuition is non-refundable.

Costume Fee

1. The costume fee pays for the dancer's costume(s). These monies are due by the due date. If no monies have been given to PowerHouse Dance by the due date, then PowerHouse Dance and its employees will believe that you are not going to be in the recital and will cancel your spot in the show. Children's costumes are \$65.00 per costume. Children's large costumes cost the same price as adult costumes. Children who need an adult size will have to pay the adult fee of \$75.00 per costume. Adult costumes are \$75.00 per costume. If your adult dancer is in need of an extra large size, then their costume will be \$85.00. Parents write down the costume size on the recital agreement form. Whatever size costume is written down by the parent, is the size of costume that will be ordered. PowerHouse Dance is not responsible for costumes that do not fit the child, since the parent writes down size they wish for PowerHouse Dance to order. We will do our best to assist you with the sizing process, so please do not hesitate to ask for our help!
2. **If a costume has to be returned or exchanged for a different size, then the parent or legal guardian will have to pay an extra fee. This fee is based on how much it costs to remake a costume and send it in time for the show.**
3. Costume and recital fees are not refundable.
4. Unfortunately those students who enroll after the recital agreement due date will not be able to participate in the recital. We are so sorry for this however we have to order them in advance to get them in time.
5. PowerHouse Dance chooses all costumes for the recital.

Recital Fee

1. The recital fee of \$50.00 is due by the due date written on the recital agreement form. Recital dress rehearsals are mandatory. If the student does not attend the dress rehearsal, they cannot participate in the recital.
2. Recital pictures are mandatory; however, you are not required to purchase them.
3. If you move before you get your costume you paid for, please know that we will not ship it to you. You are required to pick up your costume. If you do not pick up your costume by June 1st, then we will donate it.
